<u>COURSE DESCRIPTION</u>: This course is a complete overview of licensing as a broker or salesperson. It includes ethics of practice as a license holder, titles to and conveyance of real estate, legal descriptions, deeds, encumbrances and liens, distinctions between personal and real property, appraisal, finance and regulations, closing procedures, and real estate mathematics. Also covers at least three hours of classroom instruction on federal, state, and local laws relating to housing discrimination, housing credit discrimination, and community reinvestment. Fulfills the 60 hour requirement for salesperson license

<u>COURSE OBJECTIVES</u>: The student will be able to define real estate broker and salesman licensing requirements; describe conveyance of real estate procedures and considerations; summarize real estate principles including law of agency, deeds, titles, legal descriptions, encumbrances, contracts, appraisals, finance, regulations, laws governing real estate transactions and housing discrimination.

TEXTBOOKS AND MATERIALS: Students will need a copy of the book, Texas Real Estate, by: Charles J. Jacobus (13th Edition). **ISBN:** 9781629802343

<u>GRADING</u>: Grade equivalents: 90 to 100% = A; 80 to 89% = B; 70 to 79% = C; 60 to 69% = D; below 60% = F. The two lowest grades will be dropped.

The two lowest exams will be dropped. NO MAKE-UP EXAMS WILL BE GIVEN UNDER ANY CIRCUMSTANCES.

<u>ASSIGNMENTS</u>: Students are expected to attend class having **previously read the assigned chapters** and having completed all of the required assignments. Students should be prepared to discuss the readings assigned. NO LATE ASSIGNMENTS WILL BE ACCEPTED.

<u>ATTENDANCE</u>: Attendance is required as this course is IN-PERSON face-to-face instruction. Roll will not be taken. However, your attendance will impact your grade as all assignments cannot be made up. Pay close attention to the READING SCHEDULE to stay abreast of lecture and exam dates.
