GENERAL COURSE OUTLINE

Suggested Prerequisite: A valid Texas Department of Licensing and Regulation license and a high school diploma or GED.

Course Level: Intermediate

Course Description: A continuation of the fundamentals of instructing cosmetology students.

End-Of-Course Outcomes: Demonstrate effective classroom/clinic management; and implement teaching methodologies and lesson plans. Upon completion of this course the student will:

- Possess knowledge and conduct proper management of the classroom and lab. Utilize teaching methodologies.
- Prepare a notebook of lesson plans.
